2019 DEPED BICOL SYNCHRONIZED ZUMBA RUN AND TREE

PLANTING

Relative to the Unnumbered Regional Memorandum dated March 15, 2019, there will be a DepEd Bicol Synchronized Zumba Run on March 30, 2019, 5:00 am, with the theme, "Takbo Para sa Atletang Bicolano - Part 2," that will be spearheaded and managed by DepEd Region V in partnership with DepEd Bicol Association of Partnerships Coordinators, Inc. (DepED BAPC, Inc). Proceeds will be allotted for the additional financial incentives of the winner athletes and for other incidental expenses during the 2019 Palarong Pambansa in Davao City.

- 2. The activity will be synchronised in all districts/clusters/municipality in the division and shall include the following: a) Stretching/Warm-Up, b.) Fun Run, c) Short Program, d) Zumba and e) Tree Planting. Clustering is per municipality except for Pili and Ocampo whose route will start from Freedom Sports Complex, Pili and end at Camp Rodriguez-Santos, Palestina, Pili, Camarines Sur .PSDSs are also given the leeway to form clusters.
- 3. The registration fee is P150.00. Each district/cluster/municipality must determine the venue for the DepEd Bicol Synchronized Zumba Run and the area for the tree planting activities.
- 4. Participation of pupils/students who may want to join in this activity is voluntary. All Districts and schools are encouraged to invite all possible education partners from the government and non-government institution either to participate as runners or as sponsors for pupils/students.
- 5. Tree planting will also be done in support to the National Greening Program. Hence, all other concerned are advised to coordinate with their CENRO/PENRO for the seedlings. Education partners may also be invited to join the activity. District/

Cluster/Municipal Meetings must be conducted immediately in preparation for the activity.

- 6. Travel, registration and other incidental expenses of DepEd personnel can be charged against Local Funds or MOOE. Considering that March 30, 2019 falls on a Saturday, the services rendered shall be awarded with corresponding Compensatory Overtime Credits (COC) for non-teaching personnel /Service Credits for teachers, pursuant to CSC and DBM Joint Circular No. 2, s. 2004.
- 7. Registration Fees together with with the list of participants and registration forms shall be remitted/submitted to Mr. Rene Bino at the Office of the Schools Division Superintendent not later than March 26, 2019
- 8. All Districts/Clusters/Municipality are advised to organise their Technical Management Committee (TMC), designate a District/Cluster/Municipal Over-all Fun Run Coordinator and create all other committees necessary to ensure the smooth, safe, secure and successful conduct of the activity.
