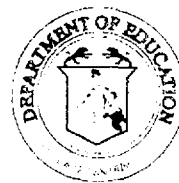

3. The ALS Accreditation and Equivalency Test Passers are required to use black pants and long sleeve for boys and casual dress for girls with white toga and graduation cap as graduation attire.

Graduation expenses for food of the Guests and ALS Implementers, Graduation Program, awards, decoration and other operational expenses shall be charged against Local Fund/SEF subject to the usual accounting and auditing rules and regulations.
