- 1. This office issues the following clarification on the evaluation and ranking of Master Teacher I and II.
- 2. Applicants must meet the Qualification Standards for the positions per MEC Order No. 10, s. 1979.

In addition to the basic requirements listed above, the candidate for MT II shall have at least an approved action research proposal within their assigned subject areas.

- 3. Applicants shall submit the following documents to the district office and endorsed by the PSDS for submission to the division office during the scheduled deliberation:
 - a. Application letter stating the position applied for;
 - b. Performance Rating for the last 3 rating periods certified by the division office
 - c. Transcript of Records and Special order authenticated by the school where the applicant has graduated
 - d. Eligibility Rating, Valid PRC license, certificate of good standing
 - e. Service Records
 - f. Class Program with summary of teaching loads, certification that the applicant is actually teaching for MT II at least 5 hours or 300 minutes and MT I,6 hours or 360 minutes.
 - g. Other documents for claims on Leadership, Potential and Equivalent for criterion A to H. Please refer to MEC Order No. 10, s. 1979.

- 4. As a revision to Division Memo. No. 82, s. of 2018, The ranking of Master Teacher I and II shall be conducted by the Division Human Resource Merit and Selection Board. All interested and qualified applicants for MT1 are required to submit their documents to the district office on the date as designated by the district.
- 5. The deliberation for MASTER TEACHER II for all applicants from the different districts will be on JUNE 20, 2018 at the Library Hub. Deadline of submission of documents shall be on JUNE 15, 2018.
- 6. The schedule of deliberation for MASTER TEACHER I for all applicants from the different districts (First, Second and Third Congressional Districts) will be:

June 28, 2018 - Lupi and Camaligan
