



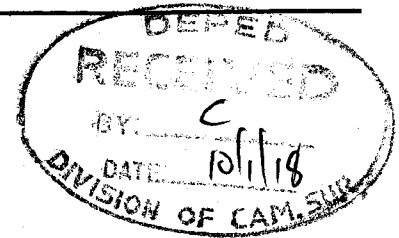

Date : September 27, 2018

1. The **Philippine Association of Speech Pathologists (PASP)** shall conduct a **seminar, free consultation, trial therapy, and home program** dissemination to **parents, teachers and children who are at risk or are already identified to have communication and/or feeding difficulties** on **October 20-21, 2018** at the venue to be announced later.

2. This **activity** aims to:

- a. introduce the speech-language pathology profession;
- b. discuss about the diagnosis, intervention, and management of communication delays and disorders;
- c. empower parents and teachers to take part in intervention and management of their children;

- e. determine the current concerns that can be worked on for the children; and
- f. provide home programs or therapy programs and demonstrators to the parents/caregivers/teachers on how to improve the skills of children.

Participants to this activity are **children who are at risk or are already identified to have communication (talking, understanding) and/or feeding (eating, swallowing) difficulties, parents, and teachers handling this kind of learners**.
