- 5. The following shall be the procedure in conducting the evaluation/ranking of applicants for this specific call up:
  - 1. The applicant submits written Letter of Application to the School where they intend to lodge their application.
  - 2. The school committee conducts demonstration and interview to the applicants.
  - 3. After the first 2 steps above, the applicant reports to the Division Selection/Sub-Committees for the evaluation of documents and for further validation. It is only in this step that they will bring their folder containing the portfolio of their claims based on the following criteria:

Education – 20 points Teaching Experience – 15 points LET/PBET Rating - 15 points Specialized Training and Skills – 10 points EPT Result (*if taken already*) – 15 points Interview – 10 points Demonstration Teaching – 15 points

Note: Applicants shall present a copy (may be a photocopy) of the result of Demonstration and Interview sheet during the evaluation.

- 6. Those who have taken the 2018 English Proficiency Test (EPT) shall no longer be allowed to take the same exam.
- The following shall be the activities for this new round of evaluation: October 17- 23, 2018 – Submission of Letter of Application to the Schools October 24 – 30 – Evaluation of Documents (SDO Conference Hall) EPT schedule shall be announced later
- 8. The Public Schools District Supervisor in-charge of the district shall facilitate the conduct of the Demonstration Teaching and Interview of the applicants with the respective school heads. They shall also consolidate the result of these two criteria to be submitted to the Office of the Assistant Schools Division Superintendent (Secondary) a day after the conduct of the activity.
- 9. Expenses incurred relative to this activity, including travel expenses of the committees are chargeable against Division/School MOOE subject to the usual accounting and auditing rules and regulations.
